#### **MEMBERSHIP NOTES**

The three maladies which effect the membership of all organizations like our local chapter of AARP are: MOVE away, FADE away and PASS away. Our membership now stands at 389 which includes 10 Complimentary; 16 Life Time; 7 Life; and, 2 Honorary members. First, the good news -103 members have already renewed their membership for 2007. Won't you join them now? 218 members paid their 2006 dues but now owe for 2007. A convenient membership renewal form is found on the last page of this Newsletter. You may want to consider becoming a Life Time member at the bargain basement price of \$100 per single / joint couple and never have to worry again about whether you owe the present year dues. Now the not-so-good news: 33 members have still not paid their 2005 dues. This fact places an undue burden on the membership committee. By recent board action, persons not paying their dues by May 1<sup>st</sup> will be dropped from the membership.

A postcard welcoming new members to our chapter is now in use. 500 copies of our November Newsletter with a cover letter were mailed to Virginia Tech retirees who are not members of our local chapter. 17 persons have already joined the chapter as a result of this mailing. We hope that a number of other retirees, who may be members of national AARP, will also choose to become members of our local chapter. #### LEGISLATIVE COMMITTEE REPORT

While the dominant topic for the upcoming session of the General Assembly is expected to be how to fund ever growing transportation needs, there are also several proposals of interest to seniors as well. Here are some items proposed by Governor Kaine. He wants to remove more than 300,000 Virginians from the tax rolls by increasing the filing thresholds for individuals and married couples. The threshold for a single filer would go from \$7,000 to \$12,000. For couples, it would go from \$12,000 to \$24,000. About half of those individuals pay taxes now. The other half have their pay docked and have to apply for refunds at the end of the year. It appears at this point that this proposal will be approved since it costs very little.

*Kaine* also proposes adding \$700,000 to help area agencies on the aging expand meal deliveries to an additional 135,000 seniors. In health care, he wants to raise the salaries of nursing instructors by 10 percent. The nursing shortage in Virginia will reach 16,000 by 2015 if nothing is done to provide more nursing educators.

Another financial problem facing Virginia, like all states is the growing cost of Medicaid. Despite having one of the nation's strictest income eligibility requirements, Virginia's Medicaid costs already make up more than 15 percent of the state's budget. As aging boomers need long-term care, costs will continue to swell. In 2005, Virginia Medicaid programs had an average of 700,000 on the rolls, about 10 percent of the state's population. The national average was about 19 percent.

The most expensive problem is finding money for long-term care for the elderly and the disabled. While they are 30 percent of Medicaid recipients, they make up 70 percent of the costs. There are bills to offer more options to people such as home and community-based care, rather than only thinking of nursing homes. As the federal debt mounts, there are efforts at the national level to dump more of the cost of Medicaid on the states as no political leaders seems to want to face up to reforming our ever deteriorating health care system.

The 2007 Advocacy agenda for AARP VA includes the following legislative priorities/goals:

\* Place in the Virginia Code the overarching public policy that prioritizes consumer choice for long-term care services.

\* Build a foundation for a Virginia-developed unified flexible financial system for the longterm care system that provides funding to follow individuals as their needs change.

\* Increase funding for additional caregiver grants.

\* Expand staffing of the Virginia Ombudsman Program.

\* Support funding for the "No Wrong Door" Initiative.

\* Support demonstration projects that better coordinate existing transportation services for seniors.

\* Support reforms to protect consumers from predatory lending.

Our chapter receives a number of "thank you" letters for donations and community service. These letters are usually shared as received with those attending Membership and Board meetings. They are then turned over to the Chapter History Committee. Recently, letters have been received from Habitat for Humanity—*Changing Lives...One House at a Time*, the Food Pantry and Blacksburg Community/Senior Center.

#### Board Minutes, January 2, 2007, Blacksburg Community/Senior Center

**9:30 a.m.** President Jim Gaines called the meeting to order. Members present: Brian Allen, Doris Abraham, Connie Anderson, Cerrie Coil, Virgil Cook, Harriett Cooper, R. B. "Ben" Crawford, Nancy Eiss, Dan Fleming, Jim Gaines, Tom Jeffers, Frank Lau, Carl McDaniels, Glen Mitchell, Mary Ellen Moore, Dale Oliver, June Schmidt, Jo Ann Underwood, Jim Wightman Adoption of Agenda: Since no agenda had been distributed, President Gaines chose to use the basic outline of a previous agenda. There were no objections.

**Programs:** Cooper expressed need for an assistant who could work her/his way into the chairmanship. Future programs: January 16 will feature Mood Swing, a group that performs primarily music from the '30's and '40's. February 20 program will feature Larry Alexander on safety at home. The safety-at-home topic turned to the need for some type of buddy system among seniors. Abraham indicated the Radford police regularly call seniors who live alone and some local churches have a buddy program. Cooper requested this be placed on the agenda of a future meeting. Anderson said that we need to gather information on available services in this area.

**Treasurer's Report:** No report. Allen will prepare a one-page summary for the newsletter. *Editors note*: no space for full report--available upon request. Report shows recent donations made to Montgomery Christmas Store, Town of Blacksburg (4 tables), Food Pantry, Community Band, RSVP, Free Clinic, Habitat for Humanity, AARP Foundation. December 06 balance \$3,798.69. **Newsletter:** President Gaines indicated that we need an editor for the newsletter. Ben and Carol Crawford wish to give up the editorship after the publication of the January issue.

President Gaines indicated he had thank-you notes from groups whose projects we supported over the past year. Allen indicated he also had several letters. Connie Anderson suggested a list of these notes be placed in the newsletter so that members would know what we are doing with their money. **Future Agenda Items:** President Gaines listed items he wishes to be included on future agendas.

1. Driver safety

2. <u>Home choices</u> for people who wish to stay at home and kinds of available services. Allen pointed to exercises people might do at home. Joy Herbert and Paul Smeal would be excellent resources. 3. <u>Tax-Aide</u>. Frank Lau reported two sites for preparing returns: the YMCA on Mondays from two to six and the Community Center on Tuesdays from 11 to three. The IRS has implemented many new restrictions. For example, preparers' computers must contain encryption software. Clients will need good identification such as photo ID's and Social Security cards, for preparers need to be sure of who you are. The YMCA will probably bring in students to help. On February 19, Frank will conduct a tax-pitfalls program at the YMCA Open University. When asked about conducting such a program for our chapter, Frank indicated that it would be better to have such a session after this year's tax season. The new tax code, which took affect on January 1 will have new requirements concerning pension plans, and taxpayers will have to keep more meticulous records of their charitable contributions. Cooper said she would plan on Frank's presenting a program in May. Allen suggested an announcement in the newsletter.

4. <u>Identity theft</u>. President Gaines wishes to organize a committee to work on this. In response to a question, President Gaines indicated that he would like both a program for a chapter meeting and formation of a committee to work on the issue.

Audit Report: Dale Oliver reported he and Ken Martin looked over the books and found them correct. A motion was made that the audit report be received. The motion passed.

**Volunteer Recognition:** Schmidt reported we have sponsored the volunteer-recognition celebration for five years--with the Red Cross, the YMCA, and what used to be the Voluntary Center, but now RSVP has come in raising the number of sponsoring organizations to four. Last year, Carilion gave us \$200, but Montgomery Regional gave us nothing whereas in the past they had donated \$300. It is difficult to determine the exact cost because RSVP, for example, cannot contribute money. Therefore, they contributed food, and the YMCA printed the programs. Oliver moved we continue the sponsorship. The motion passed.

Membership Jim Wightman handed out a report that included the following:

Membership stands at 389 which includes 18 Lifetime (\$100); 7 Life (advanced in years), 2 Honorary; 10 Complimentary; and 33 delinquent. Master copy of the mailing labels for January Newsletter will be ready 1/5/07. Copies of the membership list as of 1/5/07 will be given to Cerrie Coil [new member name tags], Kathy Jeffers [member care], and Jim Gaines [president]. **Welcome-to-our chapter** cards are being sent to new members.

500 copies of our November Newsletter were mailed to Virginia Tech retires who are not members of our local chapter. A cover letter was included citing chapter highlights and inviting them to join the local chapter. So far, 17 persons (3.5%) have joined as a result of this mailing.

<u>Motion</u>: Moved that Past Presidents of our chapter, who served 10 or more years ago, be offered Honorary or Life Membership in this chapter. <u>Background</u>: While reading our chapter history, I was struck by the fact that most of our Past Presidents who served 10 or more years ago are not presently members of our local chapter. A list of all Past Presidents is attached (not included in this newsletter). My list would include Denver Bragg (first president and active in Sports Club), Mildred Beecher (active in Sports Club?), Mary Tom Long (active in Torch Club), and Jim Owen (presently a dues paying member). It would be a plus for our chapter to offer them Honorary or Life Membership and let them know that their past service to our chapter is still appreciated. The list of past-due (did not pay for 2006) members is attached (names not included on minutes). Review before you leave today and jot down any particulars you feel I should know about before removal of the names. He asked if Joy Herbert should pay dues: she works with the chapter as a part of her job with the Town of Blacksburg and is too young for regular membership. McDaniels moved that Joy Herbert be given complimentary membership for 2007. The motion passed.

After completing his oral report, Wightman moved that past presidents who served more than 10 years ago be given honorary membership. The motion passed.

**General Assembly:** Dan Fleming reported on issues facing the upcoming General Assembly. Pundits predict a lot of gridlock on transportation. The governor is proposing a preschool program. The governor is also proposing to remove some 300,000 Virginians from the tax rolls by raising the minimum-income threshold from \$7,000 to \$12,000 for individuals and from \$14,000 to \$24,000 for couples. He is also proposing adding \$700,000 to help area agencies on aging expand meal deliveries. He wishes to raise the salaries of nursing instructors 10% to help address the projected nursing shortage. The most expensive problem is finding funding for long-term care for the elderly and the disabled. There will also be bills to expand home care and community care. Virginia is near the bottom of the list of states for per capita spending on Medicaid. Both Medicare and Medicaid are in trouble. Congress is likely to do very little because proposals must come from the administration.

Crawford reported AARP Virginia is staging a long-term-care day (a rally) at the state capitol on January 24 at 10:00 a.m. AARP may support us financially if several want to attend in a van or bus. **Accolades**: President Gaines reported that McDaniels gave a good summary of the chapter's accomplishments at the luncheon. Carl McDaniels then listed chapter accomplishments. The Chapter web site has initiated inquiries from AARP chapters around the state and nation. Things like the Website and our sound, financial footing are the kinds of things that helped make us earn Chapter of the Year. Also, the history has been well received. People from other chapters want to see the history. Crawford indicated that we have had inquiries about the history from as far away as California. Also, the AARP magazine has inquired about it. Anderson pointed out that the history is available on the Website from the link, About Us.

**Picnic**: Coil reported that we have reservations for the chapter picnic at Nellie's Cave Park for June 19. The picnic usually runs from 11 to three o'clock. Allen asked people how they felt about the auction at the picnic. Everyone agreed it was a success.
